TITLE:	Approval of Regulations for Kentucky Aerospace, Aviation, and Defense Investment Fund
DESCRIPTION	Staff recommends the Executive Committee approve the proposed regulations for Aviation Training Scholarships and Aviation Equipment Grants, on behalf of the full Council.

BACKGROUND INFORMATION

At its June 21, 2024, meeting, the Council delegated authority to the Executive Committee to review and approve on its behalf the proposed regulations for the Kentucky Aerospace, Aviation, and Defense Investment Fund in order to meet the August 1, 2024, deadline for promulgation in accordance with Senate Bill 127 (2024).

LEGISLATIVE ACTION

Enacted during the 2024 session of the Kentucky General Assembly, Senate Bill 127 created the Kentucky Aerospace, Aviation, and Defense Investment Fund to be administered by the Council on Postsecondary Education (CPE) to enable CPE and aviation industry partners to match public and private dollars to award scholarships to eligible students and equipment grants to eligible aviation programs. It is anticipated that funding for the programs will be appropriated in the next biennium.

The legislation requires CPE to reserve at least 65% of the fund for eligible aviation scholarships and to define a process for establishing contractual partnerships as outlined in 13 KAR 6:010, *Aviation Training Scholarships*. The bill also requires CPE to reserve up to 35% of the fund for aviation program equipment grants and to establish a process to determine the criteria for issuance, as outlined in 13 KAR 6:020, *Aviation Equipment Grants*. Administratively, the bill directs CPE to promulgate regulations by August 1, 2024, and requires that CPE submit draft regulations to the Interim Joint Committee on Education and the Interim Joint Committee on Transportation 30 days prior for comment and consideration.

Pursuant to the requirements of the bill, now codified in KRS 164.7011-.7021, members of the statutorily required committees were provided with draft regulations for review on June 28. Feedback was requested by July 29 in order to provide any necessary revisions to the draft

regulations before the August 1 deadline.

The next steps include:

- The promulgation (filing) of the administrative regulations by August 1 with the Administrative Regulation Review Subcommittee (ARRS) of the General Assembly;
- Future presentations will be held with stakeholders to explain the regulations in August/September;
- A public comment period will commence upon filing and conclude on September 30;
- A 90-day legislative committee review period (following the ARRS review);
- Unless deferred or found deficient, the regulations will go into effect in December 2024; and
- Each year the programs are in effect, a written report will be provided to the Council and statutorily required committees no later than December 1 of each year to include an analysis of the aviation scholarships and aviation equipment grants.

BUDGET/IMPACT

Once funded, there will be an impact on CPE's budget as a result of these programs. KRS 164.7013 allows for a portion of the Healthcare Workforce Investment Fund to be expended towards the Council's costs to administer the programs, not to exceed .5% of all gross moneys in the fund or \$75,000 annually, whichever is less.

 - (a) What this administrative regulation does:

This administrative regulation establishes the Kentucky Aviation Training Scholarships, established in KRS 164.7015, designed to reduce the financial barriers of Kentucky residents seeking high-demand eligible aviation or aerospace credentials.

(b) The necessity of this administrative regulation:

KRS 164.7013(8) requires the Council on Postsecondary Education to promulgate regulations to administer the programs related to the Kentucky aerospace, aviation, and defense investment fund. KRS 164.7015 requires the Council to set forth the requirements for partnership proposals between aviation programs and aviation industry partners to provide aviation training scholarships to Kentucky residents enrolled in eligible aviation programs in Kentucky.

(c) How this administrative regulation conforms to the content of the authorizing statutes:

The administrative regulation conforms explicitly to the authorizing statute.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes:

This regulation creates a process for issuing notice of funding opportunities, sets requirements for partnership proposals, creates an evaluation process, and a process for making awards as required by the statutes.

The number of entities affected could be dozens, if not hundreds, but none are required to participate.

- (4) Provide an analysis of how the entities referenced in paragraph (3) of this subsection will be impacted by either the implementation of this administrative regulation, if new, or by the change if it is an amendment, including:
 - (a) A detailed explanation of the actions the entities referenced in paragraph (3) of this subsection will be required to undertake in order to comply with the proposed administrative regulation: To be eligible for funding, an aviation industry partner and aviation program submit a partnership proposal. Upon proposal evaluation and subsequent award, the Council, the aviation industry partner, and aviation program shall enter into a partnership contract in accordance with the terms set forth in relevant statutes and this regulation.
 - (b) An estimate of the costs imposed on entities referenced in paragraph (3) of this subsection in order to comply with the proposed administrative regulation: The cost imposed on entities will not exceed the amount designated as their aviation industry partner contribution. There will be some administrative cost in creating and submitting a proposal.
 - (c) The benefits that may accrue to the entities referenced in paragraph (3) of this subsection as a result of compliance: Once the partnership contract is finalized, the Council shall disburse from the fund moneys deposited by the aviation industry partner and the matching funds appropriated by the General Assembly to the aviation program. This will allow the aviation program to provide scholarships to students in programs offering eligible aviation credentials as outlined in the partnership agreement. Aviation industry partners who are employers may employ these individuals upon graduation for the period to fulfill their scholarship service requirements and hopefully beyond.
- (5) Provide an estimate of how much it will cost to implement this administrative regulation:
 - (a) Initially: approximately \$150,000 once funding is received for awards to be made.
 - (b) On a continuing basis: Same as above.
- (6) What is the source of the funding to be used for the implementation and enforcement of this administrative regulation? CPE staff are currently funded from appropriations made by the General Assembly in the 2022-2024 budget. Moving forward, a portion of the general fund appropriations made to the aerospace, aviation, and defense investment fund may be used for administration pursuant to KRS 164.7013(7).

This will allow the public aviation program to maintain, acquire, or lease aviation or aviation equipment as outlined in the partnership agreement.

SUPPORTING INFORMATION

Each year, the Council reviews and approves the agency's revenue and expenditure budget for the upcoming fiscal year. Below is a description of CPE's budget as proposed for fiscal year 2024-25. The enacted state budget for 2024-2026 (primarily HB 6, but also HB 1, and SB 91), along with CPE's 2025-26 biennial budget request (submitted to the state budget office and Legislative Research Commission October 1, 2023) provide the framework for the proposed 2024-25 agency budget. Budgeted figures for the current year (i.e., 2023-24) are included for comparison.

CPE General Fund Budget

House Bill 6 provides a continuation budget for CPE. It does provide additional General Fund allocations for agency Operations, specifically for cost-of-living adjustments for staff (3% in 2024-25, and another 3% in 2025-26), though there is a reduction related to positions that were vacant in fiscal year 2023-24. The General Fund was also reduced in recognition that CPE's contributions to the state retirement system will drop from 66.17% of a participating employee's salary in 2023-24 to 48.75% next year (i.e., 2024-25).

The 2024-2026 budget provides \$2.0 million in funding for CPE to conduct a study on expansion opportunities for post-baccalaureate programs at the public universities. Funding is available in 2023-24 and can carry forward. SB 91 allows unspent funds to be used for administrative purposes.

General Fund appropriations for three programs in the Technology Trust Fund and the Doctoral Scholars Program remain the same for the upcoming biennium. General Funds in the Technology Trust Fund provide support for the Kentucky Virtual Library, Kentucky Postsecondary Education Network, and CPE's Technology Support. The Doctoral Scholars program, reinstated in 2021-22, provides scholarships and other programming to help two underrepresented minority doctoral candidates at the University of Kentucky and University of

Louisville graduate and pursue careers in academia after graduation. UK and UofL match these funds, so a total of four students benefit from this program every year.

Other General Fund appropriations are passed through to the institutions as follows:

- \$750,000 was provided for KSU oversight in the 2024-26 biennium. These funds will be used to pay for CPE staff dedicated to KSU and to continue the work of outside consultants. 2022-2024 oversight funding was \$1.5 million.
- \$7.0 million for the Healthcare Workforce Investment Fund for 2024-25, and \$3.0 million for 2025-26.
- \$1.0 million for ovarian cancer research and screening (same level as 2023-24)
- \$2.0 million for spinal cord and head injury research (same level as 2023-24)
- Finally, CPE pays the SREB dues for Kentucky, and \$10,000 was added for 2024-25 to cover cost increases.
- In special appropriations bills, CPE received \$300,000 to pass along to the National Stem Cell Foundation (NSCF) and \$8.0 million for Appalachian Regional Health (ARH).

2024-25 Operating Budget

The CPE operating budget includes most of the agency's funding for personnel and operations. Next year, CPE will use state General Fund appropriations, along with \$500,000 in Restricted Funds received by the Council for administering federal grants (i.e., primarily the GEAR UP grant), to fund agency operations. Personnel expenses make up 86 percent of the Operating budget, which is typical for state government agencies. General Fund appropriations in 2024-25 will again support 47 employees (47 employees in 2022-23 and 2023-24), which is down from 97 staff in 2007-08.

CPE's 2023-24 budget is largely a continuation budget. Next year, CPE leaders will continue to focus on the successful transition of students from secondary to postsecondary education through leadership of the P-20 Education Continuum. CPE will continue collaboration with state workforce and economic development leaders in the state and policy and programming in this area.

Tobacco Fund appropriations in CPE's budget for 2024-25 support cancer research at UK and UofL. This appropriation is divided equally.

CPE will have access to federal GEAR UP grant funds in 2024-25. GEAR UP, which stands for Gaining Early Awareness and Readiness for Undergraduate Programs, is a federally funded program that helps students in underprivileged schools prepare for postsecondary education. GEAR UP is a seven-year, \$24.5 million grant program.

The state budget provides federal funds from the State Fiscal Recovery Fund of the American Rescue Plan to CPE in 2024-25 for the Healthcare Workforce Collaborative and for Simmons College. When the amount is determined for 2024-25, CPE will seek an appropriation increase. The Healthcare Workforce Collaborative brings together public higher education officials and industry leaders to "strengthen the education and training pipeline of healthcare professions within Kentucky's public two and four-year colleges and universities." Funding for the collaborative totals \$10.0 million and is separate from the General Fund appropriation for the Healthcare Workforce Investment Fund. The state budget provides a total of \$7,280,200 for Simmons College, a private HBCU in Louisville for facilities and to "expand academic offerings

to include the areas of psychology to produce more licensed mental health practitioners, quality control technicians, and logistics and supply chain management." The Healthcare Workforce Collaborative and Simmons College will have until December 2026 to access these funds.

Restricted Funds in the CPE budget support several programs, including the Cancer Research Match program, Licensure, and Agency Operations. These funds come to CPE from a variety of sources, such as:

- Cigarette tax proceeds (i.e., one cent from each pack of cigarettes sold in Kentucky) fund the Cancer Research Match program, which is allocated to UK and UofL equally, provided the institutions are able to match the distributions with institutional funds expended on cancer research.
- Licensure fees fund the Licensure Unit. The Council licenses all Kentucky non-profit and for-profit baccalaureate degree granting and above institutions, and out-of-state public institutions operating or soliciting in the Commonwealth. The Licensure Unit also has duties related to the State Authorization Reciprocity Agreement (SARA), which allows Kentucky public and licensed institutions to do business in other SARA states. Licensure revenue of about \$400,000 per year supports the equivalent of three full-time staff members who ensure the Council's licensure duties are performed. Staff plans to use some carryforward balance to fund a significant update to the Licensure computer system. Total expenditures of \$500,000 for the year are planned.
- Finally, the Council receives funds related to the administration of federal grants and is authorized to spend those funds to support agency operations.

Other Funds

The Council manages two funds that are technically considered "off-budget," but these funds are well-known by the state budget office and the legislature. These funds are the Equine University Program Trust Fund and the Technology Trust Fund (i.e., KYVL receipts and smaller grants).

The Equine Program receives funds collected by the state related to pari-mutuel betting. The funding, traditionally about \$600,000 per year, is distributed equally to the five institutions with Equine programs (UK, UofL, MoSU, MuSU, and WKU) to help fund capital investments in their programs.

The Technology Trust Fund (TTF) receives state General Fund appropriations (mentioned above), but the fund also receives Kentucky Virtual Library (KYVL) member dues, interest earnings, private grant funds, and funds from institutions for collective purchases and state government agencies on occasion. These funds will be spent in 2024-25 as allowed by the terms of the funding.

In late May 2024, CPE received a new round of funding (\$3,250,000) from the James Graham Brown Foundation, which will be active through 2030, to fund the work of the Kentucky Student Success Collaborative at CPE. Also of note, CPE has received a \$1.5 million grant from the ECMC foundation to address student basic needs. This grant will be active through December 2026.
